Included in this collection are: genealogical materials, correspondence, printed materials, photographs, wills and estate documents, poetry, account books, diaries, journals, academic notes, deeds, religious documents and government materials.

Biographical Note

The Hayward family started with Thomas Hayward (1599-1681) immigrating from England in 1634 and settling in Bridgewater, Massachusetts. His grandson, Edward (1689-1760) and Hannah Kingsley Hayward (1690-1747) were the first to settle in Easton in 1713, and they initiated a long line of successful farmers and businessmen. Edward's sons Edward Jr. (1749-Unknown) and Joseph (1753-1843) built their homes in 1770 and continued to farm and mine bog iron, hay, cedar trees and clay for building materials. Joseph's son George Washington Hayward (1807-1880) and then his son E.R. Hayward (1837-1915) continued the family business, by adding hops to their crops and building a kiln to dry them. The Haywards were prominent members of the first church in Easton, The Church of Christ and were closely associated with George Farrar, the Reverend. Subsequent generations continued expanding in Easton and tending the family farms, until recently. Their descendants can still be found living not just in Easton, but in the homes built by their ancestors to this day.

Not much is known about Joseph Hayward (1753-1843), but he was an important man in his community. Aside from adding cranberries to the family's crops, he was a celebrated Private in his local militia in 1775. He was also a Deacon for The Church of Christ. After the hurricane of 1812, Joseph Hayward established a saw mill in order to take advantage of the numerous felled trees. Most notably, he donated the land that was to become Pine Grove Cemetery, as can be seen documented in this collection.

Elijah Hayward (1786-1864) is known for being an honored judge, supreme court justice, member of the Ohio House of Representatives, Commissioner of the General Land Office of the United States and a librarian. He is the first cousin four or five times removed of George Washington Hayward. Elijah Hayward is descended from Thomas Hayward's son John Hayward (1626-Unknown) and George Washington Hayward from his other son Joseph Hayward (1646-Unknown). Elijah Hayward was born in Bridgewater, Massachusetts to Elijah Hayward (1741-1815) and Mary Thomson Hayward (1757-1840), making him the fourth generation of John Hayward's descendants. In 1819 he immigrated to Cincinnati only to be elected as a member of the Ohio House of Representatives in 1825. A few years later, in 1830 he became a Supreme Court Justice and was commissioned by President Andrew Jackson to become the Commissioner of the General Land Office of the United States. In 1851 he was named Ohio's state librarian and used his later years to prepare briefs for the Ohio Supreme Court until his death.

George Washington Hayward (1807-1880) was another important figure in his community in Easton. He became a Captain of the East Militia Company in 1831 and would go on to pursue less militaristic accomplishments. In 1860 he built one of the earliest public libraries in Easton specifically focused on general agriculture. Later on, George Washington Hayward became the School Superintendent for five non consecutive years between 1838 and 1846. Despite these pursuits, he also managed to expand his family's iron works and began iron forge centered relationships with others in the community. He also took responsibility for adding land to Pine Grove Cemetery. In his later years he was Selectman from 1846 to 1856.

Edward Russell Hayward (1837-1915) focused on continuing the family farm and caring for Pine Grove Cemetery. In 1869 a strong gale felled many trees in Easton and he saw this event as an opportunity to add steam power to his family's saw mill. E.R. Hayward was also one of the first members of the Masonic Lodge in Easton. His sons Edward Belcher (E.B.) Hayward (1861-1948) and Chester Lincoln Hayward (1875-1958), would go on to start a successful surveying business called Hayward and Hayward.

Reverend George Farrar the Third (1730-1756) was born in Lincoln, Massachusetts, and graduated from Harvard University in 1751. He later settled in Easton in 1755, as the new pastor of The Church of Christ. George Farrar entered the Easton church community during the throes of their controversy over building a new meeting house. He stepped away from that conflict in order to visit his ill sister in Lincoln. Unfortunately, he too became sick and died there. His will and estate were written in Lincoln only days after he became ill. His widow Mary Farrar, was denied his salary and the Executor of his estate sued the Town of Easton and won.

Scope and Content Note

The papers of the Hayward Family, date from 1730 to 1940 and contain a variety of documents detailing a wide range of topics, from business transactions to daily life. Included in this collection are: genealogical materials, correspondence, printed materials, photographs, wills and estate documents, poetry, account books, diaries, journals, academic notes, deeds, religious documents and government materials. This collection is arranged into eleven series by document genre or function and is presented in alphabetical order. Subsequent organization of subseries and file levels are arranged chronologically or alphabetically, as will be specified below. Notable materials in this collection include: the will and estate inventory of George Farrar, Elijah Hayward's resignation letter to the President of The United States, photographs of the Hayward's homes, patent documents and maps of Joseph Hayward's land.

- **Series 1: Academic Notes.** The materials in this series are undated. Subseries are arranged by document genre and then into file groupings by document function. All materials are presented alphabetically. Elijah Hayward and E. B. Hayward are the primary creators of these documents. Notable materials include the twentieth century address given by George Washington Hayward and two newspapers with articles written by Eljiah Hayward.
- **Series 2: Business Transactions and Correspondence.** The materials in this series date from 1730 to 1885. The subseries arrangement is by document function and the file groupings are by document type. Subseries are presented alphabetically with their subsequent materials being ordered chronologically to follow their original order. The bulk of the materials relate to financial transactions concerning farming and Pine Grove Cemetery. The most significant materials are letters confirming the creation of a fireplace patent and farm related account books.
- Series 3: Church and Government Documents. The materials in this series date from 1819 to 1893. Subseries are arranged by document function and presented alphabetically. The materials in each subseries are ordered chronologically when dates are present and alphabetically otherwise. This series features documents relating to the Evangelical Church of Easton, specifically; meeting minutes, receipts and letters. Notable materials include: letters discussing the new Minister Luther Sheldon, a notice establishing the Evangelical Church and Elijah Hayward's letter of resignation as the Commissioner of the General Land Office to the President of the United States.
- **Series 4: Deeds and Land Documents.** The materials in this series date from 1794 to 1893. Subseries are ordered alphabetically and arranged by document type. Where dates are apparent, materials are ordered chronologically. Otherwise, individual items are ordered by their document type. Much of the material in this series relates to the layout and acreage of Joseph Hayward's land. The most notable materials are the various maps, surveyors descriptions and deeds associated with him.
- **Series 5: Diaries.** The materials in this series date from 1845 to 1879. There are no subseries and the diaries are ordered chronologically. The topics covered range from accounts of farm life and business to quick notes about recipes. There are five diaries in total and they were written by: George Washington Hayward, Kenneth Hayward (1889-1974) and E. B. Hayward. George Washington Hayward's diary contains information about his involvement with the Abolitionist Movement as well as references to prominent African American Abolitionists like Henry Bibb and Samuel Davis.

- **Series 6: Genealogical Materials.** The materials in this series date from 1860 to 1940. Subseries are arranged by family and ordered alphabetically. Further file groupings are arranged by the creator and ordered either chronologically or alphabetically, depending on if dates are present. Most materials outside file groupings are ordered chronologically or alphabetically by family. Prominent researchers featured in this series are Reverend William L. Chaffin, Louis S. Drake, Josiah Drummond and Emma Hayward Oliphant. The most significant individual item is a letter written by George Washington Hayward recounting his family history.
- **Series 7: Personal Correspondence.** The materials in this series date from 1807 to 1931. Subseries are grouped by creator and ordered alphabetically. All materials in the subseries follow chronological order. Prominent content creators are Elijah Hayward and George Washington Hunt. The topics covered in these materials include: love, travel, farming and politics.
- **Series 8: Photographs.** The materials in this series are undated. Subseries are arranged by the focal point of each photo and ordered alphabetically. Materials in each subseries follow the same arrangement and order. Most of the materials relate to the homes of Ansel Hayward, George Washington Hayward, E. B. Hayward and Joseph Hayward. Notable items in this series include: family photographs of the Haywards and interior pictures of George Washington Hayward's home.
- **Series 9: Poetry.** The materials in this series are undated. There are no subseries due to its small content size. All materials are ordered alphabetically by title when one is present. Creators and recipients are unknown. Notable topics include: love, friendship, life and general humor.
- Series 10: Wills and Estate Documents. The materials in this series date from 1757 to 1916. Subseries are arranged by the names of the deceased and ordered alphabetically. All materials located within those subseries are in chronological order. File groupings are arranged by document function and names of the deceased, respectively. The wills and estates of George Farrar, Joseph Hayward and Lydia Hayward (Unknown-1844) make up the majority of the documents. Notable materials include the wills of George Farrar and Joseph Hayward with finger-printed wax seals.

Series 11: Miscellaneous. The majority of these materials are undated, but it is estimated that they range in date from 1847 to 1933. There are no subseries and the materials are arranged by document genre. There are various Hayward family pictures, notebooks, letters and speeches. Notable items include: segments of Revered William L. Chaffin's genealogical notes, names of the members of the Evangelical Church, names of a jury, information on water lily care and a notebook of transcriptions from Elijah Hayward's journals and letters.
